Request for Proposals (RFP): Drill Water Wells on Kiowa Tribal Lands

The Kiowa Tribe Natural Resource Department, on behalf of the Department of Interior through the Bureau of Reclamation (USBR), is soliciting proposals from qualified companies for the drilling of water wells in three strategic locations within Caddo County, Oklahoma. These wells will be situated on Kiowa Tribal Lands and fall under federal jurisdiction, adhering to the guidelines set forth by the USBR program. This endeavor is aimed at bolstering the water resource program of the Kiowa Tribe and aligns with the procurement policy established by the Kiowa Tribe.

Project Overview: The selected company will be responsible for drilling water wells in three different strategic locations within Caddo County, OK, as designated by the Kiowa Tribe Natural Resource Department. The wells must adhere to all relevant federal regulations and meet the technical specifications outlined in the USBR program.

Scope of Work:

- 1. Conduct site assessments and surveys to determine optimal locations for well drilling.
- 2. Obtain all necessary permits and approvals for drilling operations on Kiowa Tribal Lands.
- 3. Drill water wells to specified depths and diameters, ensuring compliance with USBR program requirements.
