Reports To: The GAP-EPA Coordinator will be responsible for overseeing and implementing the Kiowa Tribe's GAP-EPA program. The program focuses on conservation and protection of the Tribe's natural resources, as well as ensuring compliance with environmental regulations.

HOW TO QUALIFY FOR THE JOB

Educational Requirements: Bachelor's degree in Environmental Science, Natural Resources Management, or a related field.

- Develop and implement strategies to protect the Tribe's natural resources.
- Conduct environmental assessments and monitoring activities to identify potential environmental risk and issues.
- Collaborate with other departments within the Tribe to ensure compliance with environmental regulations.
- Develop Kiowa Tribe's Management Plan.
- Work with community members and other stakeholders to raise awareness about environmental issues and promote sustainable practices.
- Develop and deliver environmental education programs to Tribal members, schools, and the broader community.
- Complete workplan commitments.
- Maintain budgets and cuff account for grant requirements.
- · Administrative duties such as filing, record keeping, and arranges travel.
- Prepare and update Quality Assurance Project Plans.
- Maintain accurate records and documentation related to the GAP-EPA program, including grant applications and reporting requirements.
- Attend meetings and events related to environmental protection and conservation, and represent the Kiowa Tribe at regional and national forums. Travel within the region to attend meetings and conferences.
